

"The following notification shall be published in an Extra-ordinary issue of the Andhra Pradesh Gazette, dt.06.06.2011.

NOTIFICATION

In exercise of the powers conferred by sub section (1) of section 3 and section 15 of the Andhra Pradesh Educational Institutions (Regulation of Admissions and Prohibition of Capitation Fee) Act, 1983 (Andhra Pradesh Act No.5 of 1983), the Governor of Andhra Pradesh hereby makes the following amendments to the Andhra Pradesh Professional Educational Institutions (Regulation of Admissions of Engineering/Pharmacy Diploma Holders into Under Graduate Professional courses through common Entrance Test) Rules, 2006 issued in G.O.Ms.No.61 Higher Education (EC) Dept dt:26.05.2006 and as amended subsequently.

AMENDMENTS

In the said rules,

1. In rule 1, in sub-rule (ii), for clause (b), the following shall be substituted, namely:-

"(b) First year of Under Graduate Professional courses in Engineering (including Technology) offered in University Colleges and Private Unaided colleges"

2. In rule 2,

(i) in clause (i), for sub-clause (m), the following shall be substituted, namely:-

"(m) "Qualified Candidate" means the candidate who passed the qualifying examination securing not less than 50% marks (45% in case of reserved categories) and who has appeared for the Common Entrance Test for admission into related Professional Course and has been assigned ranking in the Common Merit List as per Rule 6/14 of the Andhra Pradesh Engineering Common Entrance Test for Diploma Holders for admission into B.E., B.Tech., and B.Pharm Courses Rules, 2004".

(ii) for sub-clause (n), the following shall be substituted, namely,-

"(n) "Qualifying Examination" means the examination of the minimum qualification passing of which with not less than 50% marks (45% in case of reserved categories) entitles one to seek admission into the relevant professional Course as prescribed in Rule 3 of the Andhra Pradesh Engineering common Entrance Test for Diploma Holders for admission into B.E., B.Tech., and B.Pharm courses Rules, 2004".

- 3. In rule 3,
- (i) In Sub-rule (i), in clause (b), for the expression "10%", the expression "20%" shall be substituted.
- (ii) In sub-rule (ii), in clause (a), for the expression "10%", the expression "20%" shall be substituted.
- (iii) For sub-rule (iii), the following shall be substituted, namely,-

"Candidates belonging to B.Sc. stream shall be considered only after filling the supernumerary seats in this category with students belonging to the Diploma stream.

Provided that further eligible candidates shall also be eligible for admission into first year Engineering Degree courses subject to vacant seats in the first year class in case the vacant seats at lateral entry are exhausted".

4. In Rule 4,

(i) for sub-rule (ii), the following shall be substituted namely,-

"(ii) The candidate should have passed the qualifying examination of Diploma in Engineering (including Technology) and Pharmacy awarded by the State Board of Technical Education & Training of Andhra Pradesh or its equivalent secured at least 50% marks (45% in case of reserved categories) in appropriate branch of Engineering, Technology and Pharmacy or should have passed B.Sc Degree from the recognized University as defined by UGC with atleast 50% marks (45% in case of reserved categories) and passed 12th standard with Mathematics as a subject (for Engineering & Technology courses only) on the date of his/her Counseling for admission into corresponding branch of Engineering as detailed in the Annexure as per sub-rule (iii) of Rule 3 of the Andhra Pradesh Engineering Common Entrance Test for Diploma Holders for admission into B.E., B.Tech., and B.Pharm courses Rules, 2004 and the candidates should have also secured a rank at the Common Entrance test and satisfy other conditions laid down in these Rules,".

In exercise of the powers conferred by sub section (1) of section 3 and section 15 of the Andhra Pradesh Educational Institutions (Regulation of Admissions and Prohibition of Capitation Fee) Act, 1983 (Andhra Pradesh Act No.5 of 1983), the Governor of Andhra Pradesh hereby makes the following amendments to the Andhra Pradesh Professional Educational Institutions (Regulation of Admissions of Engineering/Pharmacy Diploma Holders into Under Graduate Professional courses through common Entrance Test) Rules, 2006 issued in G.O.Ms.No.61 Higher Education (EC) Dept dt:26.05.2006 and as amended subsequently.

AMENDMENTS

In the said rules,

1. In rule 1, in sub-rule (ii), for clause (b), the following shall be substituted, namely:-

"(b) First year of Under Graduate Professional courses in Engineering (including Technology) offered in University Colleges and Private Unaided colleges"

2. In rule 2,

(i) in clause (i), for sub-clause (m), the following shall be substituted, namely:-

"(m) "Qualified Candidate" means the candidate who passed the qualifying examination securing not less than 50% marks (45% in case of reserved categories) and who has appeared for the Common Entrance Test for admission into related Professional Course and has been assigned ranking in the Common Merit List as per Rule 6/14 of the Andhra Pradesh Engineering Common Entrance Test for Diploma Holders for admission into B.E., B.Tech., and B.Pharm Courses Rules, 2004".

(ii) for sub-clause (n), the following shall be substituted, namely,-

"(n) "Qualifying Examination" means the examination of the minimum qualification passing of which with not less than 50% marks (45% in case of reserved categories) entitles one to seek admission into the relevant professional Course as prescribed in Rule 3 of the Andhra Pradesh Engineering common Entrance Test for Diploma Holders for admission into B.E., B.Tech., and B.Pharm courses Rules, 2004".

- 3. In rule 3,
- (i) In Sub-rule (i), in clause (b), for the expression "10%", the expression "20%" shall be substituted.
- (ii) In sub-rule (ii), in clause (a), for the expression "10%", the expression "20%" shall be substituted.
- (iii) For sub-rule (iii), the following shall be substituted, namely,-

"Candidates belonging to B.Sc. stream shall be considered only after filling the supernumerary seats in this category with students belonging to the Diploma stream.

Provided that further eligible candidates shall also be eligible for admission into first year Engineering Degree courses subject to vacant seats in the first year class in case the vacant seats at lateral entry are exhausted".

4. In Rule 4,

(i) for sub-rule (ii), the following shall be substituted namely,-

"(ii) The candidate should have passed the qualifying examination of Diploma in Engineering (including Technology) and Pharmacy awarded by the State Board of Technical Education & Training of Andhra Pradesh or its equivalent secured at least 50% marks (45% in case of reserved categories) in appropriate branch of Engineering, Technology and Pharmacy or should have passed B.Sc Degree from the recognized University as defined by UGC with atleast 50% marks (45% in case of reserved categories) and passed 12th standard with Mathematics as a subject (for Engineering & Technology courses only) on the date of his/her Counseling for admission into corresponding branch of Engineering as detailed in the Annexure as per sub-rule (iii) of Rule 3 of the Andhra Pradesh Engineering Common Entrance Test for Diploma Holders for admission into B.E., B.Tech., and B.Pharm courses Rules, 2004 and the candidates should have also secured a rank at the Common Entrance test and satisfy other conditions laid down in these Rules,".

"(b) First year of Under Graduate Professional courses in Engineering (including Technology) offered in University Colleges and Private Unaided colleges"

2. In rule 2,

(i) in clause (i), for sub-clause (m), the following shall be substituted, namely:-

"(m) "Qualified Candidate" means the candidate who passed the qualifying examination securing not less than 50% marks (45% in case of reserved categories) and who has appeared for the Common Entrance Test for admission into related Professional Course and has been assigned ranking in the Common Merit List as per Rule 6/14 of the Andhra Pradesh Engineering Common Entrance Test for Diploma Holders for admission into B.E., B.Tech., and B.Pharm Courses Rules, 2004".

(ii) for sub-clause (n), the following shall be substituted, namely,-

"(n) "Qualifying Examination" means the examination of the minimum qualification passing of which with not less than 50% marks (45% in case of reserved categories) entitles one to seek admission into the relevant professional Course as prescribed in Rule 3 of the Andhra Pradesh Engineering common Entrance Test for Diploma Holders for admission into B.E., B.Tech., and B.Pharm courses Rules, 2004".

- 3. In rule 3,
- (i) In Sub-rule (i), in clause (b), for the expression "10%", the expression "20%" shall be substituted.
- (ii) In sub-rule (ii), in clause (a), for the expression "10%", the expression "20%" shall be substituted.
- (iii) For sub-rule (iii), the following shall be substituted, namely,-

"Candidates belonging to B.Sc. stream shall be considered only after filling the supernumerary seats in this category with students belonging to the Diploma stream.

Provided that further eligible candidates shall also be eligible for admission into first year Engineering Degree courses subject to vacant seats in the first year class in case the vacant seats at lateral entry are exhausted".

4. In Rule 4,

(i) for sub-rule (ii), the following shall be substituted namely,-

"(ii) The candidate should have passed the qualifying examination of Diploma in Engineering (including Technology) and Pharmacy awarded by the State Board of Technical Education & Training of Andhra Pradesh or its equivalent secured at least 50% marks (45% in case of reserved categories) in appropriate branch of Engineering, Technology and Pharmacy or should have passed B.Sc Degree from the recognized University as defined by UGC with atleast 50% marks (45% in case of reserved categories) and passed 12th standard with Mathematics as a subject (for Engineering & Technology courses only) on the date of his/her Counseling for admission into corresponding branch of Engineering as detailed in the Annexure as per sub-rule (iii) of Rule 3 of the Andhra Pradesh Engineering Common Entrance Test for Diploma Holders for admission into B.E., B.Tech., and B.Pharm courses Rules, 2004 and the candidates should have also secured a rank at the Common Entrance test and satisfy other conditions laid down in these Rules,".

In exercise of the powers conferred by sub section (1) of section 3 and section 15 of the Andhra Pradesh Educational Institutions (Regulation of Admissions and Prohibition of Capitation Fee) Act, 1983 (Andhra Pradesh Act No.5 of 1983), the Governor of Andhra Pradesh hereby makes the following amendments to the Andhra Pradesh Professional Educational Institutions (Regulation of Admissions of Engineering/Pharmacy Diploma Holders into Under Graduate Professional courses through common Entrance Test) Rules, 2006 issued in G.O.Ms.No.61 Higher Education (EC) Dept dt:26.05.2006 and as amended subsequently.

AMENDMENTS

In the said rules,

1. In rule 1, in sub-rule (ii), for clause (b), the following shall be substituted, namely:-

"(b) First year of Under Graduate Professional courses in Engineering (including Technology) offered in University Colleges and Private Unaided colleges"

2. In rule 2,

(i) in clause (i), for sub-clause (m), the following shall be substituted, namely:-

"(m) "Qualified Candidate" means the candidate who passed the qualifying examination securing not less than 50% marks (45% in case of reserved categories) and who has appeared for the Common Entrance Test for admission into related Professional Course and has been assigned ranking in the Common Merit List as per Rule 6/14 of the Andhra Pradesh Engineering Common Entrance Test for Diploma Holders for admission into B.E., B.Tech., and B.Pharm Courses Rules, 2004".

(ii) for sub-clause (n), the following shall be substituted, namely,-

"(n) "Qualifying Examination" means the examination of the minimum qualification passing of which with not less than 50% marks (45% in case of reserved categories) entitles one to seek admission into the relevant professional Course as prescribed in Rule 3 of the Andhra Pradesh Engineering common Entrance Test for Diploma Holders for admission into B.E., B.Tech., and B.Pharm courses Rules, 2004".

- 3. In rule 3,
- (i) In Sub-rule (i), in clause (b), for the expression "10%", the expression "20%" shall be substituted.
- (ii) In sub-rule (ii), in clause (a), for the expression "10%", the expression "20%" shall be substituted.
- (iii) For sub-rule (iii), the following shall be substituted, namely,-

"Candidates belonging to B.Sc. stream shall be considered only after filling the supernumerary seats in this category with students belonging to the Diploma stream.

Provided that further eligible candidates shall also be eligible for admission into first year Engineering Degree courses subject to vacant seats in the first year class in case the vacant seats at lateral entry are exhausted".

4. In Rule 4,

(i) for sub-rule (ii), the following shall be substituted namely,-

"(ii) The candidate should have passed the qualifying examination of Diploma in Engineering (including Technology) and Pharmacy awarded by the State Board of Technical Education & Training of Andhra Pradesh or its equivalent secured at least 50% marks (45% in case of reserved categories) in appropriate branch of Engineering, Technology and Pharmacy or should have passed B.Sc Degree from the recognized University as defined by UGC with atleast 50% marks (45% in case of reserved categories) and passed 12th standard with Mathematics as a subject (for Engineering & Technology courses only) on the date of his/her Counseling for admission into corresponding branch of Engineering as detailed in the Annexure as per sub-rule (iii) of Rule 3 of the Andhra Pradesh Engineering Common Entrance Test for Diploma Holders for admission into B.E., B.Tech., and B.Pharm courses Rules, 2004 and the candidates should have also secured a rank at the Common Entrance test and satisfy other conditions laid down in these Rules,".

NOTIFICATION

In exercise of the powers conferred by sub section (1) of section 3 and section 15 of the Andhra Pradesh Educational Institutions (Regulation of Admissions and Prohibition of Capitation Fee) Act, 1983 (Andhra Pradesh Act No.5 of 1983), the Governor of Andhra Pradesh hereby makes the following amendments to the Andhra Pradesh Professional Educational Institutions (Regulation of Admissions of Engineering/Pharmacy Diploma Holders into Under Graduate Professional courses through common Entrance Test) Rules, 2006 issued in G.O.Ms.No.61 Higher Education (EC) Dept dt:26.05.2006 and as amended subsequently.

AMENDMENTS

In the said rules,

1. In rule 1, in sub-rule (ii), for clause (b), the following shall be substituted, namely:-

"(b) First year of Under Graduate Professional courses in Engineering (including Technology) offered in University Colleges and Private Unaided colleges"

2. In rule 2,

(i) in clause (i), for sub-clause (m), the following shall be substituted, namely:-

"(m) "Qualified Candidate" means the candidate who passed the qualifying examination securing not less than 50% marks (45% in case of reserved categories) and who has appeared for the Common Entrance Test for admission into related Professional Course and has been assigned ranking in the Common Merit List as per Rule 6/14 of the Andhra Pradesh Engineering Common Entrance Test for Diploma Holders for admission into B.E., B.Tech., and B.Pharm Courses Rules, 2004".

(ii) for sub-clause (n), the following shall be substituted, namely,-

"(n) "Qualifying Examination" means the examination of the minimum qualification passing of which with not less than 50% marks (45% in case of reserved categories) entitles one to seek admission into the relevant professional Course as prescribed in Rule 3 of the Andhra Pradesh Engineering common Entrance Test for Diploma Holders for admission into B.E., B.Tech., and B.Pharm courses Rules, 2004".

- 3. In rule 3,
- (i) In Sub-rule (i), in clause (b), for the expression "10%", the expression "20%" shall be substituted.
- (ii) In sub-rule (ii), in clause (a), for the expression "10%", the expression "20%" shall be substituted.
- (iii) For sub-rule (iii), the following shall be substituted, namely,-

"Candidates belonging to B.Sc. stream shall be considered only after filling the supernumerary seats in this category with students belonging to the Diploma stream.

Provided that further eligible candidates shall also be eligible for admission into first year Engineering Degree courses subject to vacant seats in the first year class in case the vacant seats at lateral entry are exhausted".

4. In Rule 4,

(i) for sub-rule (ii), the following shall be substituted namely,-

"(ii) The candidate should have passed the qualifying examination of Diploma in Engineering (including Technology) and Pharmacy awarded by the State Board of Technical Education & Training of Andhra Pradesh or its equivalent secured at least 50% marks (45% in case of reserved categories) in appropriate branch of Engineering, Technology and Pharmacy or should have passed B.Sc Degree from the recognized University as defined by UGC with atleast 50% marks (45% in case of reserved categories) and passed 12th standard with Mathematics as a subject (for Engineering & Technology courses only) on the date of his/her Counseling for admission into corresponding branch of Engineering as detailed in the Annexure as per sub-rule (iii) of Rule 3 of the Andhra Pradesh Engineering Common Entrance Test for Diploma Holders for admission into B.E., B.Tech., and B.Pharm courses Rules, 2004 and the candidates should have also secured a rank at the Common Entrance test and satisfy other conditions laid down in these Rules,".
