

# Admission Procedure

## **B.Tech Programmes (Four Year Courses):**

### **Admissions under Convenor's Quota (A- Category)---70% of intake in each branch:**

A Candidate for admission to the four-year degree course in Engineering must have passed the Intermediate examination of the Board of Intermediate Education, Government of Andhra Pradesh with Mathematics, Physics and Chemistry as Major subjects, or any other examination recognized by the University as equivalent thereto. All the eligible applicants for admission into First Year shall have to qualify in the EAMCET Examination conducted by the Govt. of AP. The candidates will be admitted strictly in accordance with the merit secured at the Entrance Examination keeping in view the rules in force regarding the reservations of seats of various categories of candidates. The candidates should satisfy local/non-local status requirement as laid down in the AP Educational institutions (Regulation of Admissions) Order 1974 as amended from time to time.

### **Admissions under Management Quota (B- Category)----30% of intake in each branch:**

B- Category seats are filled by the Management of the college following the guidelines stipulated by APSICHE, Guntur.

## **B.Tech Programmes (Three Year Programmes for Diploma/B.Sc Holders)**

Of the sanctioned intake in a branch of engineering 10% seats as supernumerary seats are allotted to Diploma and B.Sc holders for admission into II Year B.Tech directly. Admissions into II Year B.Tech through lateral entry for Diploma and B.Sc Holders are conducted by The Convener, ECET. Admissions through web counselling based on the rank obtained by the candidates in ECET keeping in view the rules in force regarding the reservations of seats of various categories of candidates

There are no B – Category (Management Quota) Seats for lateral entry into II Year B.Tech.

## **M.Tech Programmes**

### **Admissions under Convenor's Quota (A- Category)----70% of intake in each specialization:**

Admissions for A – Category Seats are conducted by the Convener, PGECET. Admissions through web counselling based on the rank obtained by the candidates in GATE/PGECET keeping in view the rules in force regarding the reservations of seats of various categories of candidates. The admissions are also based on course wise eligibility rules of JNTU GV.

### **Admissions under Management Quota (B- Category)----30% of intake in each specialization:**

Admission to B – Category Seats are done by the college Management following the guidelines of APSICHE, Guntur, The B – Category admissions done by the college are subject to ratification by APSICHE and JNTU GV.

## **MBA Programme**

### **Admissions under Convenor's Quota (A- Category)-----70% of intake:**

Admissions for A – Category Seats are conducted by the Convener, ICET keeping in view the rules in force regarding the reservations of seats of various categories of candidates

### **Admissions under Management Quota (B- Category)-----30% of intake:**

Admission to B – Category Seats are done by the college Management following the guidelines of Government of Andhra Pradesh (APSCHE). The B – Category admissions done by the college are subject to ratification by APSCHE and JNTU GV.

### **Eligibility**

The candidate should have passed the qualifying examination (10+2+3) .
