Review of In-house R&D, Consultancy Preparations for NAAC Accreditation Review of Placements for 2023 Outgoing Batch

- 1. Action Taken Report on the minutes of 29th meeting held on 25-06-2022. IQAC coordinator presented the activities since the last meeting and chair person requested the members to give their suggestions regarding the action taken report. List of activities implemented based on the minutes of previous meeting are as follows.
 - i. Members critically reviewed the status of AQARs 2021-22, and observed a satisfactory progress in spite of the pandemic situation.
 - ii. Members reviewed the Results and Feedbacks of 2021-22 and observed a satisfactory progress in spite of the pandemic situation for all the departments enabling continuous improvement.
 - iii. Members critically reviewed the In-house R&D, Consultancy
 - iv. Members reviewed the Preparations for Placements for 2022 Outgoing Batch
 - Members critically reviewed the progress of Preparatory work to NAAC 3rd cycle of Accreditation.

2. Motivating staff and students towards Certification programs

Chairman, IQAC has informed about the importance of certification by NPTEL of our students and faculty members in the pursuit of quality. Chairman said that number of registrations in NPTEL courses from faculty members is very less in number. Chairman instructed all the heads of the departments that every faculty member must register for at least one NPTEL course and complete at the earliest. It has been

decided to compensate the registration fees for faculty members to obtain certification from NPTEL.

Resolution: It is resolved that every faculty member and student must register and complete at least one NPTEL course at the earliest.

3. AR20 assessment process

Chairman, IQAC has advised all the departments to start the assessment process of AR20 courses and as per the guide lines of AICTE. Principal asserted to perform the assessments with focus on the following aspects: Open Elective from II Year II Semester, Professional Elective from III Year I Semester, Internship, mini projects, Course in employability skills.

It is decided to implement AR20 assessments from the academic year 2021-22. The chairman instructed to prepare the Assessment process manual for the AR20 regulations.

4. Curriculum design of AR20 CSE & AIML

Chairman, IQAC has apprised all the departments to start curriculum design process of IV years of AR20 regulations as per the guide lines of AICTE and AISHE. Principal asserted to focus on latest technologies to be introduced in lab courses. Chairman advised to get the approval for the contents of IV year courses of AR20 regulations in the BOS and academic council.

Resolution:

The chairman instructed to prepare the IV year CSE course contents and be prepared for BoS.

5. Review on Honors Courses:

Chairman, IQAC has apprised all the departments to identify 4 courses for each Honors Courses and prepare the content as per AR20 regulations and as per the guide lines of AICTE. Principal asserted to For B.Tech Honors course students were identified as per the minimum CGPA 8.5 & above (Or) not more than the 35% of the Admitted Intake.

Resolution:

The chairman instructed to prepare the course contents and be prepared for BoS.

6. Any other points to be discussed with the permission of the Chair person
