- Action Taken Report on the minutes of 31<sup>st</sup> meeting held on 17-12-2022. IQAC coordinator presented the activities since the last meeting and chair person requested the members to give their suggestions regarding the action taken report. List of activities implemented based on the minutes of previous meeting are as follows.
  - Members critically reviewed the progress of CO, PO, PSO Attainment reports of B.Tech. ECE, CSE, EEE, IT, Civil, ME Programs and expressed a satisfactory opinion.
  - Members critically reviewed the status of NPTEL/ Course-era certification courses for students and faculty members and observed an incremental trend in the number of certification courses
  - iii. Members reviewed the Research Publications of faculty members and students and observed an incremental trend in the number of Research Publications.

#### 2. Strengthening the measures for Plastic free campus

Chairman, IQAC and all other members stressed upon the strengthening the existing measures to move towards the plastic free campus. It is suggested to arrange the awareness programmes for all the students and staff regarding the ill effects of usage of plastics. It is also resolved to strictly ban single use plastic items in the campus. It is also suggested to organize NSS rallies in the surrounding villages to create awareness among the public regarding the usage of plastic in general and single use plastic in particular.

**Resolution:** It is resolved to organize awareness programmes for all the staff members and students regarding the ill effects of usage of plastics. It is also resolved to strictly ban the usage of single use plastics in the campus in general and in the hostels and canteen in particular. Rallies by NSS in the surrounding villages are planned to create the awareness among the public regarding the usage of plastics.

Chairman, IQAC stressed upon the mandatory submission of AQAR of 2021-22 academic year within in the given deadline and advised the members to speed up the data consolidation for timely submission of AQAR in spite of the pandemic situation.
